To achieve this mission, our members pledge to uphold the following Code of Ethics:

- Conduct our business in a manner that will reflect credit upon the Built Green program.
- Agree to not become involved in any situation which would tend to degrade the Member or Built Green in the community or which brings the Member or Built Green into public disrepute, contempt, or scandal, regardless of whether the information becomes public.
- Avoid statements or implications that may be misleading or deceptive.
- Describe accurately and honestly the price, materials, methods and standards of workmanship used in Built Green projects.
- Provide high standards of health and safety.
- Deal fairly with everyone involved in our projects including employees, subcontractors, suppliers and customers.
- Perform to the standards of the NAHB Residential Construction Performance Guidelines in effect at the time of construction.
- Offer a minimum one-year written warranty on new homes and remodels, and use the MBA's consumer dispute resource program to settle disagreements with builders and remodelers of single-family homes should the Association receive a complaint.
- Certify that as a contractor member of Built Green, we are registered, bonded and insured with the State of Washington.
- Use the Built Green logo truthfully and according to the program's logo standards.

Built Green and the Master Builders Association, in their sole discretion, reserve the right to deny or remove membership based on failure to adhere to the Code of Ethics.
